We are encouraged to see movement forward in all of our fields as our missionary teams continue to pursue engaging in relationships within their regions. The way To Every Tribe teams do this is through pursuing the *Phases in Pioneer Church Planting* within a *Regional Approach to Church Planting*. In 2021, we saw donations increase ministry-wide at nearly four percent. We also saw our overall expenses increase as we began to see costs of items such as insurance, professional services, and travel increase globally. As part of our commitment to financial transparency and accountability, we also began the process in 2021 of applying for accreditation from the Evangelical Council for Financial Accountability (ECFA) and, subsequently, received accreditation in early 2022.


